## Thien Long Announces Q1 2025 Business Results

## **Financial Overview**

- Net revenue in Q1 2025: VND 794.4 billion, a slight decrease of 1.8% YoY, achieving 19% of the annual target.
- NPAT MI in Q1 2025: VND 78.9 billion, down 10.7% YoY, achieving 18% of the annual target.

The first quarter is traditionally the low season in the business cycle of the stationery industry. During this period, domestic revenue recorded modest growth, while export revenue declined year-overyear, primarily due to short-term impacts from natural disasters and seasonal factors in our traditional export markets. Nevertheless, we anticipate a recovery and a return to growth momentum in export revenue over the subsequent quarters.

As of the end of Q1/2025, Thien Long had achieved 19% of its annual revenue target and 18% of its annual profit target – laying a solid foundation for strong acceleration in Q2, which is traditionally the Company's peak season. The gross profit margin remained high at 42.8%, demonstrating solid cost control and operational optimization capabilities.
